



Gippsland PHN general practice data analysed for Latrobe Health Advocate

February 2020

Background

Gippsland PHN are supporting an 'Access to Services' project by the Latrobe Health Advocate. At a meeting held 14 January 2020, it was decided that Gippsland PHN do a high level analysis of general practice data based on the following ideas:

- Focus on Latrobe LGA residents to answer questions such as;
 - How many people are accessing Latrobe clinics?
 - How many are accessing clinics outside Latrobe?
 - How many people from outside Latrobe are accessing Latrobe clinics?
 - Who in Latrobe is accessing GP services? Population demographics
 - When are Latrobe residents accessing GP services? After hours / weekends...
- What are the top ten health issues (based on GP diagnosis) for Latrobe residents?
- Anything else that may be useful

Patient overview

Patients with a residential postcode in Latrobe City and activity in any general practice in Gippsland using POLAR¹ in 2019 were included.

In Latrobe City, there are 26 general practices and 18 practices (or 69%) are included in the POLAR database.

Notes on data limitations:

- Patient counts do not represent unique patients (patients who visit more than one practice will be included more than once in the patient count)
- Geography is not exact as postcodes cross LGA boundaries

In total, 90,937 patients with a residential address in Latrobe City and general practice activity in 2019 were identified. Figure 1 shows the proportion in Latrobe City practices;

- 85.1% in Latrobe City practices (Figure 1)
- 14.9% in practices outside Latrobe City
- 74.2% (or 67,470 patients) had at least three activities in the same practice over two years (RACGP active), and of these patients;






Figure 2. Location of general practice use by residents of Latrobe City with at least three activities in the same general practice over two years (RACGP active), n=67,470.

 - 90.4% used a Latrobe City practice (Figure 2)
 - o 9.6% used a practice outside Latrobe City

Figure 1. Location of general practice use by residents of Latrobe City, with activity in 2019, n=90,937.

Activities in general practice

Patient activities in a general practice include usual consultations of different lengths with a general practitioner, but can also include telehealth consultations, nurse or allied health consults, visits to a patient's home (including Residential Aged Care facilities), phone calls, emails and electronic messages (SMS). Not all of these activity types are billable through the Medicare Benefits Schedule.

The after-hours period is defined as:

- Before 8.00am and after 6.00pm weekdays
- Before 8.00am and after 12.00pm Saturdays
- All day Sundays and public holidays
